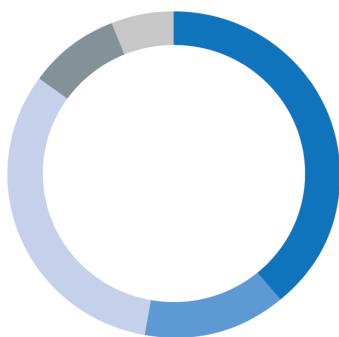

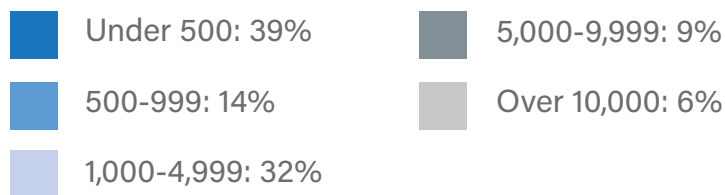

Product Options:

Comprehensive, Reporting-only, Letter 226-J Response Support

Key Differentiators:

Timing:

Must be implemented by October 31 to avoid delays in form generation and IRS filings

Billing Services

Product Options:

Timing:

Can be implemented any time, but should avoid overlapping with open enrollment

Timing:

Can be implemented any time, but should avoid overlapping with open enrollment
